The mission of the Old Columban Society, founded in 1909, is to keep Old Columbans in touch with one another and with the College, and also to support the College.

In this spirit, the Old Columban Society established the OCS Bursary Fund in 2011 to support children and grandchildren of Old Columbans.

For various reasons, some OC families have been unable to meet the full cost of the College fees. The purpose of the Fund is to offer financial assistance to these individuals. Any monies donated go directly to support OC families in paying their fees.

To maintain and nurture this Fund, the OCS encourages its members to commit to a suggested amount of €21 per month or €250 per year or whatever they are able to donate.
